Child and Family Welcome Letter

Dear Family,

Welcome to Main Line Neuropsychology. Your child has been referred for an intake interview. This appointment will help determine how I might best be able to assist you and your child. The intake will take approximately 45 minutes and will involve parent and child interviews. You will then be provided with feedback and recommendations, which commonly include testing or therapy services, depending on your family's needs. Both you and your child should attend the appointment.

Several forms have been provided for you to complete prior to your appointment. Please complete the History Form, Evaluation Consent Form, and Record Release Form (indicating which provider you would like the report to be sent to or me to speak to). The Privacy Practices Notice is included for you to read; please complete the Privacy Practice Consent Form indicating that you have read the notice. If charges are being submitted to your insurance company, complete the Insurance Form for precertification and claim purposes. Please also make a copy of your child's insurance card and your driver's license. Please email/fax me all of the insurance information (Insurance Form, Insurance Card, Driver's License) at least one week before your first appointment so that we can contact your insurance company to obtain your benefit information and gain authorization for the evaluation. If you are interested in psychological or neuropsychological testing, please have your child's doctor complete a script/referral (if needed) recommending these services. Bring in the remaining forms to your appointment, along with copies of any previous psychological, medical, neuropsychological, and school reports (e.g., school evaluation report, standardized testing, grades), that would be helpful for me to review. Of note, if the patient is 18 or older, the patient will need to sign some of the forms.

The child's primary guardian needs to be present for the appointment, or I will need to be provided with a signed letter stating that the guardian gives permission for the evaluation. If divorced, please bring a copy of the divorce decree, stating who has primary guardianship. If both divorced parents have guardianship, and only one is present for the evaluation, then I will need a signed letter from the other parent stating he/she agrees to the assessment.

Main Line Neuropsychology is located at 30 S. Valley Road, Suite, 207, Paoli, PA 19301. The office is just off of Route 30/Lancaster Avenue. The office is located on the main floor of the building, which you get to from the main entrance (Suite 207). Please have a seat and I will be with you shortly.
